The Deputy Director/Specialist, Lands Department has under section 15(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 15(5) of the Ordinance, the Director of Civil Engineering and Development, his officers, workmen, contractors, employees, servants, agents, licensees and any other persons authorized or permitted by the Director of Civil Engineering and Development be given full rights and liberty to enter upon the said land for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus in connection with the Scheme.
