

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1944EM16T, Triennial Term Contract for the Maintenance and Repair of, Alterations and Additions to Fire Services Installations for Health Services Buildings in Hong Kong Region and Outlying Islands**. The scope of works for this Contract includes maintenance, repair, alterations and additions of fire service installations in the venues of the Health Services Buildings in the Hong Kong Region and Outlying Islands.
