NOTICE OF PREQUALIFICATION OF TENDERERS

It is intended to invite tenders in 1st Quarter of 2018 from prequalified tenderers for Contract No. SS G501—Design and Construction of Immigration Headquarters in Area 67, Tseung Kwan O. The tenders to be invited will be covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The scope of works of the contract comprises the design and construction of Immigration Headquarters, with net operational floor area of around 57 400 m<sup>2</sup>, to provide general office accommodation and frontline services to the public for Immigration Department. The anticipated commencement and completion dates of the contract will be around 1st Quarter of 2019 and 4th Quarter of 2022 respectively.

Applicants meeting the following requirements:—

1. The applicant or at least one participant/shareholder in a joint venture applicant is on the List of Approved Contractors for Public Works, Buildings Category Group C (Confirmed) ('the List'),
2. The applicant or any one of the participants/shareholders in a joint venture applicant has completed at least one building contract in Design and Build arrangement, in or outside Hong Kong with an adjusted original contract sum not less than HK\$700 million with substantial building services installations (including plumbing and drainage) not less than an adjusted original contract value of HK\$140 million within the past 10 years counting from and including the original date set for the close of receipt of prequalification submission (i.e. between 24 May 2007 and 23 May 2017). Only such contracts with substantial completion date falling within the above stated period will be considered,
3. Where the applicant is a joint venture applicant:—
  - (i) the total percentage of participation of participants/shareholders who are contractors on the List shall be at least 40%;
  - (ii) the lead participant/major shareholder, who is NOT a contractor on the List, shall satisfy the criteria of satisfactory completion as the main contractor of two building contracts, in or outside Hong Kong, each of a value not less than the limit on the values of contract or works that may be undertaken by Group C (probationary) contractors in the List of Approved Contractors for Public Works, Buildings Category as set out in the Contractor Management Handbook within the past 7 years counting from and including the original date set for the close of receipt of prequalification submission (i.e. between 24 May 2010 and 23 May 2017). Only such contracts with substantial completion date falling within the above stated period will be considered; and
  - (iii) any participant other than the lead participant or any shareholder other than the major shareholder, who is NOT a contractor on the List, each participant/shareholder shall satisfy the minimum technical and management criteria set out in the Contractor Management Handbook for direct entry to the probationary status in the List of Approved Contractors for Public Works, Buildings Category Group C.

and other qualifications and conditions for participation stipulated in the prequalification documents are invited to apply for prequalification.

A charge will be levied for delivery of the prequalification documents where the delivery of prequalification documents is requested by an applicant. A written request must be made.

Not more than five applicants will be selected for tender invitations in accordance with the evaluation criteria stipulated in the prequalification documents.

Completed prequalification applications shall be submitted not later than 12.00 noon on Tuesday, 23 May 2017 to General Registry, Room 4123a at the above address. Prequalification application shall be prepared in English. Late applications will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Tuesday, 23 May 2017, the closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 has been replaced by a lower signal.

Joint ventures satisfying the requirements stated in the prequalification documents will be considered.

The Government of the Hong Kong Special Administrative Region reserves the right to reject any application and to negotiate with any applicants about the terms of their offers.
