

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1273EM17T—Quadrennial Term Contract for Maintenance of Liquefied Petroleum Gas Installations at Various Venues of Transport, Security and Central Services Division**. The scope of the works includes inspection, maintenance, testing, repair, alteration, addition and improvement of the liquefied petroleum gas installations at various venues of Transport, Security and Central Services Division. The Contract is scheduled to commence in June 2018 for expiry in May 2022.
