

It is hereby notified that sealed tenders in triplicate are invited for the **Contract No.: 3116EM17T, Triennial Term Contract for Operation and Maintenance of Air-conditioning Installations and Other Associated Facilities at Attended Municipal Venues in Kowloon**. The scope of the works includes operation and maintenance Air-conditioning Installations at various Municipal Venues in Kowloon. The contract period is tentatively from June 2018 to May 2021.
