

It is hereby notified that sealed tenders in triplicate are invited for the **Contract No.: 3117EM17T, 42-month Term Contract for Maintenance of Air-conditioning Installations and Other Associated Facilities at Unattended Municipal Venues in Kowloon**. The scope of the works includes maintenance of air-conditioning installation and other associated installations at various Municipal Venues in Kowloon. The contract period is tentatively from June 2018 to November 2021.
