

It is hereby notified that sealed tender in triplicate is invited for the **Provision of Light Goods Vehicles for Hiring by Hongkong Post as a 24-month service contract from the date as specified on the letter of acceptance (Tender Ref.: HKP 201805).**

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated on the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon (Hong Kong Time) on 12 April 2019. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If a Black Rainstorm Warning Signal or Tropical Cyclone Signal No. 8 or above is hoisted at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the closing date of the tender as stated above, the tender closing time will be postponed to 12.00 noon on the first working day after the Black Rainstorm Warning Signal has ceased to be in effect or the Tropical Cyclone Signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
