Tenders must be clearly marked with the tender reference and the subject of the tender on the envelope which bear no indication that may relate the tender to the tenderer, addressed to 'The Chairman, Government Logistics Department Tender Opening Committee' and placed in the Government Logistics Department Tender Box ('Specified Tender Box') on the Ground Floor of the North Point Government Offices at 333, Java Road, North Point, Hong Kong, before 12.00 noon (Hong Kong Time) on Thursday, 24 February 2022. Tenders must be deposited in the Specified Tender Box before the tender closing time. Late tender or tender not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above, a black rainstorm warning signal or 'extreme conditions after super typhoon' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Thursday, 24 February 2022, the tender closing time will be postponed to 12.00 noon (Hong Kong Time) on the first working day after no tropical cyclone signal No. 8 or above is in force or the black rainstorm warning signal or the 'extreme conditions after super typhoon' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Thursday, 24 February 2022, the Government will announce the tender closing time will be extended until further notice.
