It has been brought to my attention that the following building works have been carried out in or at the above premises:

- (i) An inward swinging metal gate installed at the exit of the front staircase on G/F leading to Lan Fong Road.

2. For the said building works:
- (a) As a result of the building works at item (i) above, Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened.
3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-
- (a) Demolish the said building works described under item (i) above; and
- (b) Reinstatement of the parts of the building so affected by the building works under item (i) above in accordance with the plans approved by the Building Authority.
- Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.
4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.

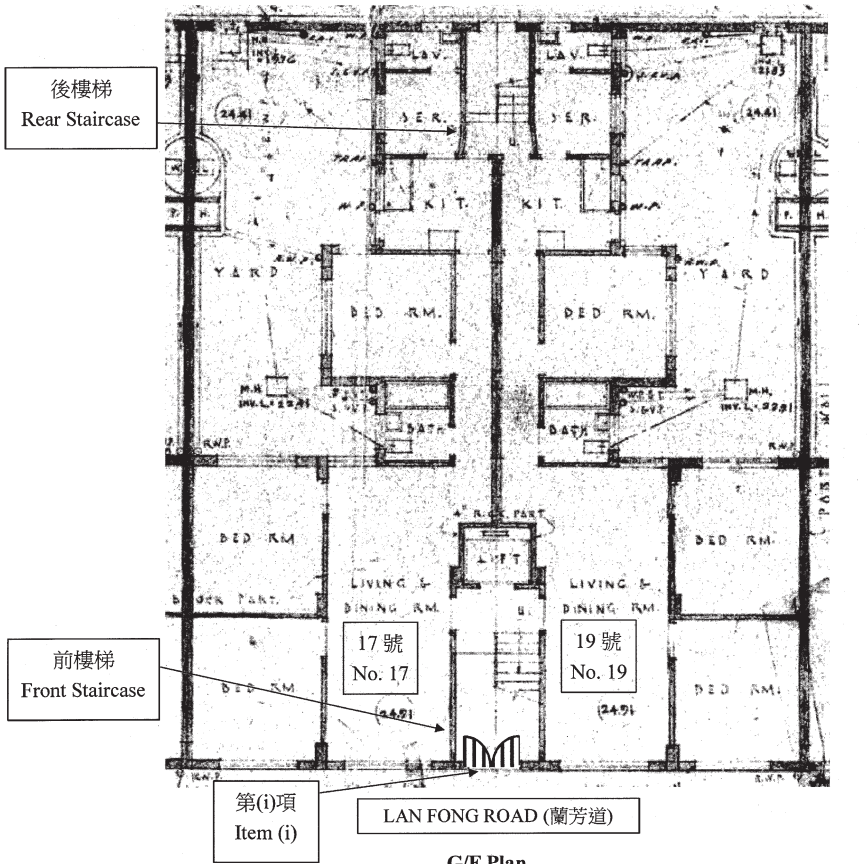
