

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS M508—Construction of a 12-classroom Special School at Oi Kwan Road, Wan Chai (Programme No. 115ET)**.

The works include the construction of a 12-classroom special school comprising a 7-storey classroom block with an assembly hall and associated facilities for children with mild intellectual disability, together with piled foundation, drainage, external works and demolition of existing building. The construction floor area is approximately 6 800 square metres. The contract is scheduled to commence in August 2023 and for completion in May 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 24 February 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 24 February 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 24 February 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Groups B or C for Buildings Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the above-mentioned approved list/category/group who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (1) the tenderer or in case of a joint venture tenderer, the lead participant/major shareholder in the joint venture tenderer must be a probationary or confirmed Group B or probationary or confirmed Group C contractor on the List of Approved Contractors for Public Works for Buildings Category as at the original date set for the close of tender or, if this has been extended, the extended date; and
- (2) the tenderer must have completed at least one building contract in or outside Hong Kong with an adjusted original contract sum not less than HK\$160 million within the past 10 years counting from and including the original date set for the close of tender (i.e. between 25 February 2013 and 24 February 2023 inclusive). Only such contracts with substantial completion date falling within the above stated period will be considered.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by Thursday, 26 January 2023 to Chief Quantity Surveyor/1 of Architectural Services Department, at 33/F, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications and conditions for
