

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. ND/ 2024/06, Fanling North New Development Area, Remaining Phase: Fresh Water and Flushing Water Service Reservoirs and Associated Works (Public Works Programme Item No. 7828CL-2)**. The works include:—

1. construction of a fresh water service reservoir, a flushing water service reservoir and associated site formation, geotechnical, roadworks, power supply, drainage and landscaping works;
2. laying of about 5.7-kilometre-long fresh water mains and about 5.7-kilometre-long flushing water mains;
3. installation of pumps and associated electrical and mechanical works within Shek Wu Hui Water Reclamation Plant constructed by the Water Supplies Department; and
4. implementation of environmental mitigation measures for the works mentioned above.

The works are scheduled to commence in the third quarter of 2024 and will take about 40 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 1 March 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 1 March 2024, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 1 March 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Confirmed contractors on the List of Approved Contractors for Public Works in Group C under the Waterworks Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a confirmed contractor on the List of Approved Contractors for Public Works in Group C under the Waterworks Category, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least one construction contract involving waterworks or site formation works with an adjusted original contract sum not less than HK\$600 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted original contract sum shall be the contract sum at the time of contract award being adjusted to current price level as specified in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Waterworks Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned

approved list/category by 30 January 2024 to Chief Engineer/North 1, North Development Office, Civil Engineering and Development Department, at Unit 1501, Level 15, Tower I, Metroplaza, 223 Hing Fong Road, Kwai Fong, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
