Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Hong Kong Housing Authority and placed in the HA Tender Box located at the Regional Management Office/Taipo, North and Shatin, Estate Management Division, Wing A, Level 4, Hong Kong Housing Authority Customer Service Centre, 3 Wang Tau Hom South Road, Kowloon, Hong Kong before 10.00 a.m. on Friday, 26 January 2024 (Hong Kong Time).

Late tenders or tenders not submitted in accordance with the above or the requirements stipulated in the Tender Document shall not be accepted.

The tender closing time and date will automatically be deferred to 10.00 a.m. (Hong Kong Time) on the following Monday or the next earliest possible working day (excluding Saturday) of the following week in the following circumstances:—

- (a) if Tropical Cyclone Warning Signal No. 8 or above is hoisted and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (b) if a ‘Black’ Rainstorm Warning Signal is issued or ‘extreme conditions after super typhoons’ is announced by the Government (*via* the Information Services Department) within two (2) hours before the tender closing time and/or remains in force beyond the tender closing time on the tender closing date; or
- (c) when the Director of Housing announces the closure of the Housing Authority Headquarters Building due to unforeseen circumstances occurring within two (2) hours before the tender closing time and/or remains closed beyond the tender closing time on the tender closing date.

For the avoidance of doubt, the Tender Closing Time and the Tender Closing Date will remain unchanged if the Tropical Cyclone Warning Signal No. 8 or above or the ‘Black’ Rainstorm Warning Signal or ‘extreme conditions after super typhoons’ is lowered or cancelled, or the Housing Authority Headquarters Building is reopened, two (2) hours or more before the tender closing time on the tender closing date.

The Hong Kong Housing Authority does not bind itself to accept the lowest tender or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer or cancel the tendering exercise.
