

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1098EM22T, titled 'Triennial Term Contract for the Comprehensive Maintenance and Repair of Lift Installations at Various Premises of Hospital Authority (SC22)'**. The scope of the Works includes comprehensive maintenance and repair of lift installations (SC22) at various premises of the Hospital Authority. The Contract is scheduled to commence in November 2022 for expiry in October 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in Public Works Tender Box located in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 22 April 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 22 April 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 22 April 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Lift, Escalator and Passenger Conveyor Installation' or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Lift, Escalator and Passenger Conveyor Installation' who also meet the following qualifications and conditions for participation stipulated in the tender documents are invited to tender:—

- (1) a tenderer shall be a registered lift contractor under the Laws of Hong Kong, Lifts and Escalators Ordinance (Chapter 618); and
- (2) a tenderer has completed lift maintenance contracts in or outside Hong Kong within the past 5 years with the minimum accumulated awarded contract sum of not less than HK\$30 million; and
- (3) a tenderer shall not have any consecutive adverse reports on performance in any contracts of Electrical and Mechanical Services Trading Fund (EMSTF), on-going or completed, with the last day of the reporting period as specified in the report falling within the 9-month assessment period (inclusive of the first and last day of the 9-month assessment period).

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Lift, Escalator and Passenger Conveyor Installation' may also submit a tender if they submit a request for participation together with a duly completed
