

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1568EM23T—Quadrennial Term Contract for Maintenance of Fire Service Installations for Hong Kong Police Force, Correctional Services Department, Drainage Services Department, Fire Services Department, Independent Commission Against Corruption and Security Bureau for Hong Kong Island and Outlying Islands**. The scope of the works includes maintenance, repair, alteration and addition services of fire service installations for the venues of the Hong Kong Police Force, Correctional Services Department, Drainage Services Department, Fire Services Department, Independent Commission Against Corruption and Security Bureau. The contract is scheduled to commence in February 2025 for expiry in January 2029.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503, 5/F, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 12 April 2024. Tenders must be deposited in the tender box as specified in the tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 12 April 2024, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 12 April 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
