

ROAD TRAFFIC (TRAFFIC CONTROL) REGULATIONS (Chapter 374G)

CLOSED ROADS IN HONG KONG-ZHUHAI-MACAO BRIDGE
HONG KONG PORT AND HONG KONG LINK ROAD

In exercise of the powers vested in me under regulation 27(1) of the Road Traffic (Traffic Control) Regulations, Chapter 374G, I hereby direct that with effect from 10.00 a.m. on 10 March 2023, the following sections of roads in Hong Kong-Zhuhai-Macao Bridge Hong Kong Port (Hong Kong Port) and Hong Kong-Zhuhai-Macao Bridge Hong Kong Link Road (Hong Kong Link Road) will be closed to all vehicles 24 hours daily, except those with permits issued by the Commissioner for Transport or exempted from the Road Traffic (Registration and Licensing of Vehicles) Regulations, Chapter 374E under regulation 3(c) of the Road Traffic (Registration and Licensing of Vehicles) Regulations:—

- (a) Hong Kong-Zhuhai-Macao Bridge Hong Kong Link Road;
- (b) the unnamed access road connecting Hong Kong Link Road eastbound and the Highway Maintenance Area;
- (c) the unnamed access road connecting Hong Kong Link Road westbound and the Highway Maintenance Area;
- (d) the cross-boundary coach and cross-boundary shuttle bus pick-up area at the Hong Kong Port;
- (e) the cross-boundary coach and cross-boundary shuttle bus drop-off area at the Hong Kong Port;
- (f) Shun Hang Road;
- (g) Shun Wan Road;
- (h) Shun Ngon Road;
- (i) the section of Shun Lui Road between Hong Kong Link Road and a point about 165 metres from its junction with Shun Wui Road;
- (j) the unnamed access road to the west of the Passenger Clearance Building connecting to Shun Lui Road;
- (k) the unnamed access road to the east of the Passenger Clearance Building between its junction with Shun Lin Road, Shun Hang Road and the cross-boundary coach and cross-boundary shuttle bus drop-off area;
- (l) the unnamed access road connecting the cross-boundary coach and cross-boundary shuttle bus drop-off area to Shun Hang Road;
- (m) the unnamed access road connecting Shun Lui Road to Shun Hang Road and the cross-boundary coach and cross-boundary shuttle bus pick-up area;
- (n) the unnamed section of road to the west of the cross-boundary coach and cross-boundary shuttle bus pick-up area between its two junctions with Shun Lui Road;
- (o) the section of the unnamed road between its two junctions with Shun Wan Road;
- (p) the section of the unnamed road between its junction with Chek Lap Kok Road eastbound at about 1 055 metres east of Sky City Interchange and Hong Kong Link Road;
- (q) the section of the unnamed road between its junction with Shun Long Road westbound at about 345 metres east of the junction of Shun Long Road westbound and Chek Lap Kok Road westbound and the unnamed section of road in item (p) above;
- (r) the section of the unnamed road between Hong Kong Link Road and its junction with Chek Lap Kok Road westbound;
- (s) the section of the unnamed road between item (r) above and its junction with Shun Long Road eastbound;
- (t) all section of the unnamed roads between item (p) above and Shun Wan Road;
- (u) all section of the unnamed roads between item (p) above and Shun Ngon Road;
- (v) all section of the unnamed roads between item (r) above and Shun Ngon Road;
- (w) all section of the unnamed roads between their junctions with Shun Ngon Road;
- (x) all section of the unnamed roads between items (o) and (r) above; and
- (y) all *cul-de-sacs* leading to and from Shun Ngon Road as well as item (t) above.

The road closure will be indicated by appropriate traffic signs.
