**Merchant Shipping (Local Vessels) (Safety and Survey)
(Amendment) Regulation 2023**

(Made by the Secretary for Transport and Logistics under section 89
of the Merchant Shipping (Local Vessels) Ordinance (Cap. 548))

1. Commencement

This Regulation comes into operation on 5 May 2023.

Local Vessels to which Section 81(1) of this Regulation Does Not Apply

Part 1

Class II Vessels

1. A Class II vessel that—
 - (a) is not a gas carrier;
 - (b) is fitted with an engine that uses gaseous fuel;
and
 - (c) is constructed and equipped for the safe use of
gaseous fuel.

2. A Class II vessel that—
 - (a) is a gas carrier;
 - (b) is fitted with an engine that uses gaseous fuel;
and
 - (c) is constructed and equipped for the safe
carrying of liquefied gases in bulk.

Part 2

Class III Vessels

3. A Class III vessel that falls within paragraph (a) of
Schedule 2.

-
4. A Class III vessel that—
- (a) is made of glass reinforced plastic;
 - (b) is of less than 15 m in length;
 - (c) has a total engine power not exceeding—
 - (i) for a vessel of 5 m or more but less than 6 m in length—30 kW;
 - (ii) for a vessel of 6 m or more but less than 8 m in length—56 kW; or
 - (iii) for a vessel of 8 m or more but less than 15 m in length—67 kW; and
 - (d) is equipped with the following life-saving appliances and fire-fighting apparatus, all of which are in good and serviceable condition—
 - (i) at least 1 lifejacket for every person on board;
 - (ii) at least 1 lifebuoy;
 - (iii) for a vessel of less than 8 m in length—at least 1 portable dry powder fire extinguisher that has a capacity of not less than 2.7 kg of dry powder, and 1 fire bucket that is fitted with a lanyard; and
 - (iv) for a vessel of 8 m or more in length—at least 2 portable dry powder fire extinguishers, each of capacity of not less than 2.7 kg of dry powder, and 2 fire buckets, each fitted with a lanyard.”.

Explanatory Note

This Regulation amends the Merchant Shipping (Local Vessels) (Safety and Survey) Regulation (Cap. 548 sub. leg. G) (**Cap. 548G**) mainly to—

- (a) subject gas carriers to the requirements relating to survey records of safety equipment under Division 2 of Part 5 of Cap. 548G;
- (b) subject gas carriers to the requirements relating to automatic identification systems under section 80A of Cap. 548G;
- (c) provide that the restriction on the use of certain engines under section 81(1) of Cap. 548G does not apply to—
 - (i) certain Class II vessels (not being a gas carrier but fitted with an engine that uses gaseous fuel) that are constructed and equipped for the safe use of gaseous fuel; or
 - (ii) certain gas carriers that are constructed and equipped for the safe carrying of liquefied gases in bulk;
- (d) specify that gas carriers are Category A vessels;
- (e) add a new Table 6B to Part 2 of Schedule 4 to Cap. 548G to prescribe the requirements relating to fire-fighting apparatus for gas carriers;
- (f) subject gas carriers to the requirements relating to Hong Kong load line certificates; and
- (g) require gas carriers to comply with the requirements of the Merchant Shipping (Prevention of Oil Pollution) Regulations (Cap. 413 sub. leg. A).
