Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Hong Kong Housing Authority and placed in the Tender Box located at the Ground Floor, Block 2 of the Hong Kong Housing Authority Headquarters at 33 Fat Kwong Street, Ho Man Tin, Kowloon, Hong Kong, before 10.00 a.m. on 29 April 2022 (Hong Kong Time).

Late tenders or tenders not deposited in the specified Tender Box will not be accepted.

The tender closing time will automatically be deferred to 10.00 a.m. on the first working day (excluding Saturday) in the following circumstances:—

- (a) if tropical cyclone warning signal No. 8 or above is hoisted and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date;
- (b) if a black rainstorm warning signal or 'extreme conditions after super typhoons' is announced by the Government (*via* the Information Services Department) and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (c) when the Director of Housing announces the closure of the Housing Authority Headquarters Building due to unforeseen circumstances and the Housing Authority Headquarters Building remains closed for any duration within two (2) hours before the tender closing time on the tender closing date.

For the avoidance of doubt, the tender closing time will remain unchanged if black rainstorm warning signal or tropical cyclone signal No. 8 or above or 'extreme conditions after super typhoons' is lowered or cancelled or the Housing Authority Headquarters Building is reopened, two (2) hours or more before the tender closing time on the tender closing date.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The Hong Kong Housing Authority does not bind itself to accept the highest combined score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
