ROAD WORKS UNDER YUEN LONG SOUTH DEVELOPMENT  
STAGE 1 WORKS AND STAGE 2 WORKS, PHASE 1

Notice is hereby given that under section 11(2)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Chief Executive in Council has authorized the works and the use as described in G.N. 1637 published on 26 March 2021 and 1 April 2021 with modifications described hereunder. The modifications include modifications to limit of works area, as shown on Modification Plans Nos. 60566218/GAZ/102A and 60566218/GAZ/103A ('the Modification Plans'); and modifications to resumption/clearance limit, as shown on Modification Resumption Plan No. YLM10809 ('the Modification Resumption Plan'). The Modification Plans and the Modification Resumption Plan have been deposited in the Land Registry.

The modifications are as follows:—

- (i) revision of the proposed limit of works area; and
- (ii) revision of the resumption/clearance limit in relation to modification as described in (i) above, including reduction of the extent of proposed land resumption of Lots Nos. 1423 RP, 1427 RP, 1428 RP, 1429 RP and 1467 S.B all in D.D.121.
