Notice is hereby given that under section 11(2)(b) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation, the Chief Executive in Council has authorised the sewerage works and the use as described in G.N. 1634 published on 26 March 2021 and 1 April 2021 with modification as shown on Modification Plan No. 60566218/GAZ/402A ('the Modification Plan') and described hereunder. The Modification Plan has been deposited in the Land Registry.

The modification is as follows:—
