

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2157EM21T, Triennial Term Contract for Maintenance and Repair of Vehicle Examination Equipment for Transport Department Vehicle Examination Complex of Transport Department for the Government of HKSAR**. The scope of the Works includes the comprehensive maintenance and repair services of Vehicle Examination Equipment and Related Electronic Equipment for Transport Department Vehicle Examination Complex of Transport Department for the Government of HKSAR. The Contract is scheduled to commence in July 2022 for expiry in July 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 29 April 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
