

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1029EM22T—Quadrennial Term Contract for Provision of Maintenance, Modification and Installation Works for Area Traffic Control System.**

The scope of the works includes maintenance, modification and installation works for the Area Traffic Control (ATC) System and provision of first line maintenance for traffic signals and accessories equipment. The Contract is scheduled to commence in December 2022 for expiry in November 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 6 May 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 6 May 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/has ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 6 May 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The tenderer shall have completed contract(s) for supply, installation, modification or maintenance of traffic signal controller and audible traffic signal in Hong Kong with an aggregate contract value of not less than HK\$23.9 million within the past 5-year period immediately preceding the tender closing date specified in the Government Gazette to tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this experience requirement.
