

## ROAD TRAFFIC ORDINANCE (Chapter 374)

(Notice under section 78)

COMPULSORY VEHICLE EXAMINATION  
VEHICLE EXAMINATION CENTRE

Notice is hereby given under section 78(1)(d) and 78(1A)(b) of Road Traffic Ordinance (Chapter 374) that save for vehicles listed in paragraph 4 below, all the following vehicles which are one or more years old after the first registration, have previously been issued with a vehicle licence, and require a new vehicle licence (whether or not upon expiry of the current licence) commencing on or after 24 January 2022:—

- (1) taxis;
- (2) goods vehicles;
- (3) special purpose vehicles;
- (4) light buses;
- (5) buses; and
- (6) trailers

shall before licensing be produced for examination at one of the vehicle examination centres listed in paragraph 3 below.

An appointment for examination of the vehicle concerned may be made at a vehicle examination centre. No appointment shall be made 4 months earlier than the expiry date of the vehicle licence concerned.

This Notice does not apply to the following vehicles:—

- (i) light goods vehicles not exceeding 1.9 tonnes permitted gross vehicle weight, which have been examined at a car testing centre designated under section 88C(1) of the Ordinance before licensing;
- (ii) vehicles for which the Commissioner has separately given notices to their owners that no vehicle examination is required.

This Notice, which supersedes any notices previously made under section 78(1)(d) of the Ordinance, shall commence on 24 January 2022.
