Explanatory Note

This Order sets aside 6 places for use as public pleasure grounds.

2. The Order also provides that 4 places cease to be set aside for use as public pleasure grounds.
3. Accordingly, the Order amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—
 - (a) add the 6 places mentioned in paragraph 1; and
 - (b) remove the 4 places mentioned in paragraph 2.
