Explanatory Note

This Order sets aside 6 places for use as public pleasure grounds.

- 2. The Order also provides that 4 places cease to be set aside for use as public pleasure grounds.
- 3. Accordingly, the Order amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—
 - (a) add the 6 places mentioned in paragraph 1; and
 - (b) remove the 4 places mentioned in paragraph 2.
