Explanatory Note Paragraph 1

Explanatory Note

This Notice amends Schedules 2 and 3 to the Road Traffic (Breath Analysing Instruments, Screening Devices and Prescreening Devices) Notice (Cap. 374 sub. leg. S) (*principal Notice*) to add Alcotest 6820—

- (a) as an approved screening device for indicating whether the proportion of alcohol in a person's breath is likely to exceed the prescribed limit; and
- (b) as an approved pre-screening device for indicating whether the proportion of alcohol in a person's breath reaches a level that it would be reasonable to suspect that that proportion is likely to exceed the prescribed limit.
- 2. The Notice also removes Alcotest 7410 from Schedule 2 to the principal Notice so that Alcotest 7410 is no longer an approved screening device for the purposes of the Road Traffic Ordinance (Cap. 374).
- 3. Furthermore, the Notice makes minor textual amendments to the Chinese text of Schedules 2 and 3 to the principal Notice to achieve consistency.
