

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. NL/2023/09—Tung Chung New Town Extension—Infrastructure Works at Ying Hei Road and Tung Chung Waterfront Road (Public Works Programme Item No. 7898CL)**. The works mainly include:—

- (a) construction of covered four-span footbridge systems at the junction of Tung Chung Waterfront Road and Yi Tung Road and the junction of Ying Hei Road and Ying Tung Road, covered staircases and lifts;
- (a) construction of noise barriers on a section of Ying Hei Road and Tung Chung Waterfront Road;
- (b) construction of low-noise road surfacing on a section of Ying Hei Road and Tung Chung Waterfront Road;
- (c) construction of cycle tracks near Tung Chung Development Pier; and
- (d) ancillary works including landscaping, drainage, street lighting and utilities works, as well as installation of street furniture and traffic aids.

The works are scheduled to commence in late 2024/early 2025 and will take about 27 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 17 May 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 17 May 2024, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 17 May 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least one roads and drainage construction contract with an adjusted contract value of not less than HK\$300 million, in or outside Hong Kong, within the past 5 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned

approved list/category by 26 April 2024 to Chief Engineer/Lantau 2, Sustainable Lantau Office, Civil Engineering and Development Department at 13th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
