## PROPOSED ROAD IMPROVEMENT WORKS AT HOI SHA PATH, CHEUNG SHA, LANTAU ISLAND

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. ISM3578 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of pedestrian crossings;
- (ii) permanent closure and conversion of sections of the existing carriageway into footpaths and run-ins/run-outs;
- (iii) permanent closure and conversion of sections of the existing footpaths into sections of a carriageway;
- (iv) permanent closure and conversion of sections of the existing amenity areas into sections of a carriageway and footpaths;
- (v) demolition and conversion of sections of the existing slopes into sections of a carriageway and footpaths;
- (vi) permanent closure of sections of the existing carriageway and footpaths;
- (vii) temporary closure and reconstruction of sections of the existing carriageway and footpaths; and
- (viii) ancillary works including slope works, retaining wall, geotechnical, electrical, mechanical, drainage, landscaping, street lighting and utility works.

The lots to be resumed as shown on Resumption Plan No. ISM3586 ('the Resumption Plan') annexed to the scheme are listed below:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Any objection lodged on a ground relating to any compensation (whether monetary or non-monetary) or any financial or other assistance in connection with the works or the use is, to the extent that it is lodged on that ground, invalid and treated as not having been lodged for the purposes of section 11 of the Ordinance. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than 27th day of May 2024.

## Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to further process the objections/comments if such information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
