

**INDEX OF AMENDMENTS TO OR REPEALS OF ORDINANCES  
PUBLISHED IN THE LOOSE-LEAF EDITION OF THE LAWS OF  
HONG KONG AS UPDATED BY THE LATEST ISSUE (ISSUE 66)**

**(To 31.3.2022)**

This index lists amendments to Ordinances published in the Loose-leaf Edition of the Laws of Hong Kong (as updated by the latest issue (i.e. Issue 66)), or repeals of such Ordinances, that are not reflected in that issue. Following each item is the enactment that amends or repeals the Ordinance concerned. The enactment is printed in bold type if it is gazetted in March 2022.

2. This index is published monthly. Users should refer to the individual Legal Supplements to the Gazette to see whether an Ordinance is amended or repealed by another enactment after the date of the index.

3. The Hong Kong e-Legislation (**HKeL**) (<https://www.elegislation.gov.hk>) was launched on 24 February 2017. Verified copies of legislation printed from HKeL are presumed to correctly state the legislation (see section 5 of the Legislation Publication Ordinance (Cap. 614)). The legislation data in HKeL are being progressively verified.

4. If an existing Ordinance published in the Loose-leaf Edition is verified and becomes available in HKeL, it will cease to be updated in the Loose-leaf Edition. Instead, a purple Check List will be published in the next issue of replacement pages to direct users to HKeL. Further, new principal Ordinances published in the Gazette after 2 June 2016 will not be published in the Loose-leaf Edition but will be made available in HKeL. Such new principal Ordinances and Ordinances replaced by purple Check Lists are not covered by this index.

5. Users may refer to HKeL to see whether a verified copy of an Ordinance is available in HKeL. If an Ordinance with a verified copy available in HKeL is amended or repealed by another enactment, HKeL will be updated by consolidating the amendment or repeal that has come into operation, or by recording the amendment or repeal that has not yet come into operation in a notice (that could be found under “Provisions / Amendments not yet in operation” in HKeL).
