Where an announcement has been made for the extension of the tender closing time until further notice, upon the removal of the blockage or inaccessibility, the Government will as soon as practicable announce the revised tender closing time. Late tenders and tenders not deposited in the Government Secretariat Tender Box in accordance with the aforesaid provisions will not be accepted.
