The Plan and scheme were referred to in G.N. 6840 published on 2 December 2016 and 9 December 2016. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 2 May 2022 to 1 May 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central reserves/refuge islands, pedestrian crossings and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered inclined lift system with two inclined lifts on the slope between Tai Wo Hau Road and Wo Tong Tsui Street, the construction of footpaths at Tai Wo Hau Road and Wo Tong Tsui Street and other ancillary works.
