## PERMANENT ROAD CLOSURE OF A SECTION OF KAM PO ROAD

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway, footpaths and verge; and to close temporarily sections of the existing carriageways, footpaths, cycle tracks, central reserves/refuge islands, verges, run-ins/run-outs and pedestrian crossings within the limit of works area as shown on Plan No. HNTDM21-062 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 327 published on 21 January 2022 and 28 January 2022. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 29 April 2022, all public or private rights in, upon, under or over the sections of the existing carriageway, footpaths and verge to be permanently closed, shall be extinguished; and from 29 April 2022 to 28 April 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, cycle tracks, central reserves/refuge islands, werges, run-ins/run-outs and pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the permanent closure of a section of Kam Po Road of about 180 metres long between Kam Wui Road and Tung Wui Road; and permanent closure and conversion of a section of Kam Po Road of about 120 metres long between Tung Wui Road and the maintenance ramp of Kam Tin River into maintenance access for the transitional housing development at Lot 2160 RP in D.D. 106 and adjoining government land in Kam Tin, Yuen Long.

This notice will be affixed on or near the affected carriageways, footpaths, cycle tracks, central reserves/refuge islands, verges, run-ins/run-outs and pedestrian crossings on 29 April 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
