

It is hereby notified that tenders are invited for **Contract No. CV/2023/09, Site Formation and Infrastructure Works at Cheung Muk Tau (Public Works Programme Item No. B807CL)**. The works mainly comprise site formation works, construction of access road, road improvement works and the ancillary works including drainage, sewerage, waterworks and landscaping works. The works are scheduled to commence in the third quarter of 2023 and will take about 64 months to complete.

Tenderers must submit completed tenders in both soft and hard copies. The soft copy of the completed tenders must be submitted *via* the e-Tendering System and the hard copy must be placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The hard copy of the tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Both hard and soft copies must be submitted before 12.00 noon on Friday, 2 June 2023. Late tenders or soft copy of tenders not submitted *via* the e-Tendering System or hard copy of tenders not deposited in the Specified Tender Box will not be accepted.

For tender submission made *via* the e-Tendering System, tenderers should ensure that data transmission must be completed before the tender closing time. Tenderers are required to use the organizational e-Cert to sign the tender before submission *via* the e-Tendering System. Attention is drawn to the time required for the certification authority to issue the organizational e-Cert. Tenderers are advised to apply for organizational e-Cert well in advance of the tender closing date. Tenderers should ensure that the accounts of the e-Tendering System are valid well in advance of the tender closing date. Tenderers with invalid accounts or accounts without valid passwords will not be able to access the e-Tendering System to download the tender documents, submit tender queries and tenders. The hard copy of sealed tenders in duplicate must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 2 June 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 2 June 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made *via* press releases on the website of Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Site Formation Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Site Formation Category, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least one (1) construction contract involving site formation works or roads and drainage works with an adjusted contract value not less than

HK\$180 million, in or outside Hong Kong, within the past ten (10) years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Site Formation Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 17 May 2023 to Project Team Leader/Housing, Civil Engineering and Development Department at Units 01, 05-09 of 35/F One Kowloon, 1 Wang Yuen Street, Kowloon Bay, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
