TUNG CHUNG LINE EXTENSION

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF
SHUN TUNG ROAD, TAT TUNG ROAD, YI TUNG ROAD,
TUNG CHUNG WATERFRONT ROAD AND YING HEI ROAD, AND
PART OF THE OPEN SPACE BETWEEN
PHASE 1 AND PHASE 2 OF TUNG CHUNG CRESCENT**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 19 April 2023 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Shun Tung Road between a point about 45 metres south of its junction with Tung Chung Waterfront Road and a point about 650 metres southeast of the junction, as delineated and shown in yellow on the Plan numbered TCLE/G03/0001/1;
- (II) the temporary partial closure of the section of Tat Tung Road between its junction with Shun Tung Road and a point about 60 metres northeast of the junction (near Tung Chung Swimming Pool), as delineated and shown in orange on the Plan numbered TCLE/G03/0001/1;
- (III) the temporary partial closure of the section of Tat Tung Road between its junction with Shun Tung Road and a point about 50 metres northeast of the junction (near Fu Tung Estate), as delineated and shown in purple on the Plan numbered TCLE/G03/0001/1;
- (IV) the temporary closure of part of the open space between Phase 1 and Phase 2 of Tung Chung Crescent, as delineated and shown in red on the Plan numbered TCLE/G03/0001/1;
- (V) the temporary partial closure of the section of Yi Tung Road between a point about 85 metres north of its junction with Tung Chung Waterfront Road and a point about 60 metres south of the junction, as delineated and shown in green on the Plan numbered TCLE/G06/0001/1; and

(VI) the temporary partial closure of the section of Tung Chung Waterfront Road between its junction with Yi Tung Road and a point about 50 metres west of the junction, and the section of Ying Hei Road between its junction with Yi Tung Road and a point about 50 metres east of the junction, as delineated and shown in blue and pink respectively on the Plan numbered TCLE/G06/0001/1,

during the period from 12 May 2023 to 11 May 2024 for the purposes of or incidental to the railway scheme of the Tung Chung Line Extension. A description of the works to be carried out, the sections of the roads and the part of the open space to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered TCLE/G03/0001/1 and TCLE/G06/0001/1 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the roads and the open space affected by the Order on 28 April 2023.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of the roads and the open space or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads and the open space affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of the roads and the open space or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
