- 注意**
- (i) 須為每名受僱於石棉工作的人分別備存健康登記冊。
 - (ii) 此健康登記冊須附有由進行健康檢查的醫生所簽發的證明書。
 - (iii) 健康登記冊須保存為期最少 5 年，自登記冊內最後一項項項的日期起計。
 - (iv) 在健康登記冊所涉的人在僱用終止時，東主須給予該人一份健康登記冊的副本。
 - (v) 任何東主不遵守工廠及工業經營(石棉)規例第17(3)條為受僱於石棉工作的人備存健康登記冊，即屬犯罪，可處第 4 級罰款。
- Note**
- (i) A separate health register shall be maintained for each person employed in asbestos work.
 - (ii) The certificate issued by the medical practitioner conducting the examination shall be attached to this health register.
 - (iii) Health register shall be kept for at least 5 years from the date of last entry in the register.
 - (iv) A copy of the health register shall be given to the person covered by it upon termination of his employment.
 - (v) A proprietor who fails to maintain health register for person employed in asbestos work in accordance with section 17(3) of the Factories and Industrial Undertakings (Asbestos) Regulation commits an offence and is liable to a fine at level 4.
