The Plan and scheme were referred to in G.N. 471 published on 29 January 2016 and 5 February 2016. The First Amendment Plan and first amendment scheme were referred to in G.N. 6327 published on 11 November 2016 and 18 November 2016. The Second Amendment Plan and second amendment scheme were referred to in G.N. 8701 published on 23 November 2018 and 30 November 2018. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 18 May 2022 to 17 May 2023, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered footbridge with associated lifts and lift tower, staircase/escalator structure, covered staircases, covered escalators, footbridge columns and other ancillary works.
