

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

TUNG CHUNG NEW TOWN EXTENSION  
(WIDENING OF TUNG CHUNG ROAD NORTH)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, amenity areas and staircase within the limit of works area as shown on Plan No. RD/GZ004 ('the Plan') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. RD/GZ004A and RD/GZ004A/LEGEND ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plan and scheme were referred to in G.N. 3764 published on 25 May 2018 and 1 June 2018. The Amendment Plans and amendment scheme were referred to in G.N. 2674 published on 18 April 2019 and 26 April 2019. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 17 May 2022 to 16 May 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, amenity areas and staircase to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve widening of the existing Tung Chung Road North to a single two-lane carriageway.

A copy of the order, the Plan and the Amendment Plans may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageways, footpaths, amenity areas and staircase on 6 May 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
