

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

AIRPORT TUNG CHUNG LINK

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. C21C04/GAZ/001, C21C04/GAZ/010 to C21C04/GAZ/018 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of elevated carriageways, elevated footpaths, at-grade carriageways, footpaths cum amenity areas, footbridges, escalators, staircases, lifts and pedestrian crossings;
- (ii) permanent closure and conversion of sections of the existing at-grade carriageways into footpaths, footpaths cum amenity areas and a traffic island;
- (iii) permanent closure and conversion of sections of the existing footpaths into at-grade carriageways and cycle parking areas;
- (iv) permanent closure and conversion of sections of the existing amenity areas into at-grade carriageways, footpaths, footpaths cum amenity areas, a cycle track, cycle parking areas and a vehicle maintenance and stabling area;
- (v) permanent closure and conversion of sections of the existing cycle track into footpaths and cycle parking areas;
- (vi) permanent closure and conversion of a section of the existing cycle parking area into a footpath;
- (vii) permanent closure and conversion of the existing traffic island into an at-grade carriageway;
- (viii) temporary closure and reconstruction of sections of the existing at-grade carriageway, footpaths, amenity areas and cycle track;
- (ix) Government foreshore and/or sea-bed to be affected by/reclaimed for the construction of foundation works of the proposed elevated carriageway; and
- (x) ancillary works including site formation, landscaping, drainage, waterworks, utilities, street lighting, electrical and mechanical works, construction of retaining walls as well as installation of street furniture and traffic aids.

The area where rights of temporary occupation of land are to be created as shown on Plan for Creation of Rights of Temporary Occupation of Land No. ISM3605 ('the Plan for Creation of Rights of Temporary Occupation of Land') annexed to the scheme is listed below:—

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Logistics an objection in writing, which can be submitted *via* one of the following means:—

- (1) By post or by hand to the Transport and Logistics Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Any objection lodged on a ground relating to any compensation (whether monetary or non-monetary) or any financial or other assistance in connection with the works or the use is, to the extent that it is lodged on that ground, invalid and treated as not having been lodged for the purposes of section 11 of the Ordinance. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 25th day of June 2024.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to further process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
