1. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-

- (a) reinstate the parts of the building so affected by the building works under items (i) to (vi) below in accordance with the plans approved by the Building Authority.

- (i) A canopy attached to the external wall on Ground Floor of the premises facing House 1;
- (ii) A structure attached to the external wall on Ground Floor of the premises facing The Cairnhill;
- (iii) A projecting structure attached to the external wall on First Floor of the premises facing The Cairnhill, an unauthorized opening formed on the external wall on First Floor facing The Cairnhill with installation of a door, providing access to the flower box;
- (iv) A projecting structure on and over the flower box, and attached to the external wall on First Floor of the premises facing The Cairnhill;
- (v) A structure erected on and over the main roof of the premises; and
- (vi) Steps constructed at Ground Floor main entrance of the premises.

(The location of the building works described above is shown hatched-black on the plan annexed hereto, for the purpose of identification only.)

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

2. You are required to commence the works ordered by me in paragraph 1 above within **30** days and complete such works within **60** days of the date of this order, all to the satisfaction of the Building Authority.

3. For the said building works in paragraph 1 above:
- (a) The building works at items (i) to (vi) above has been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance.

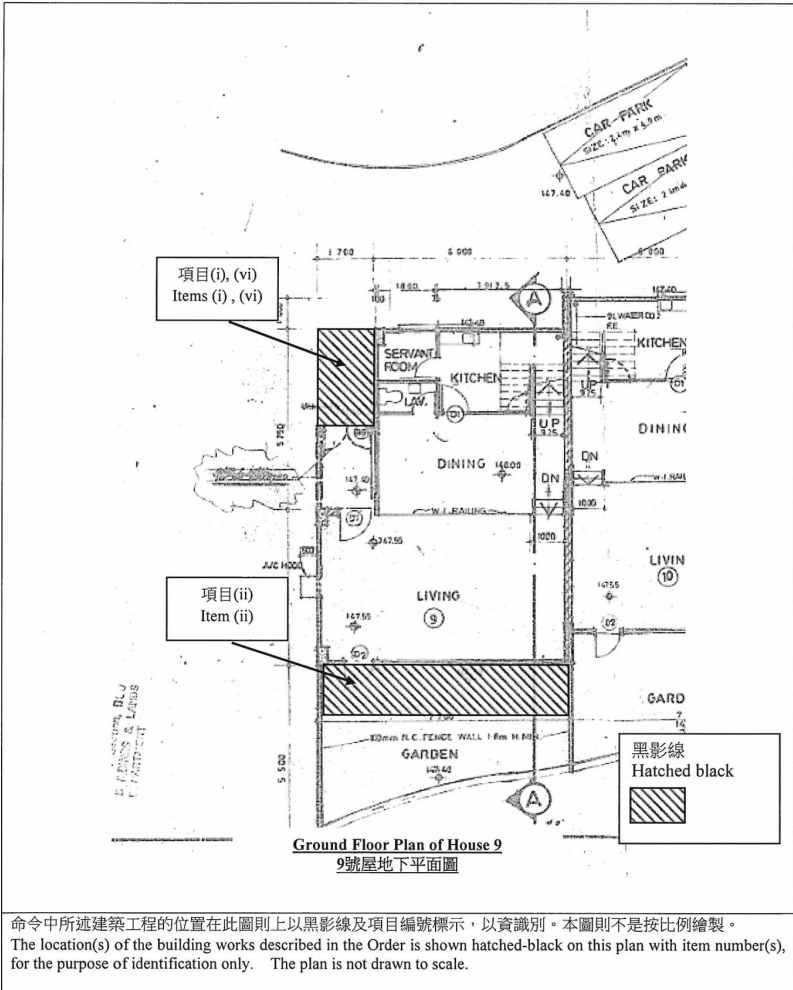

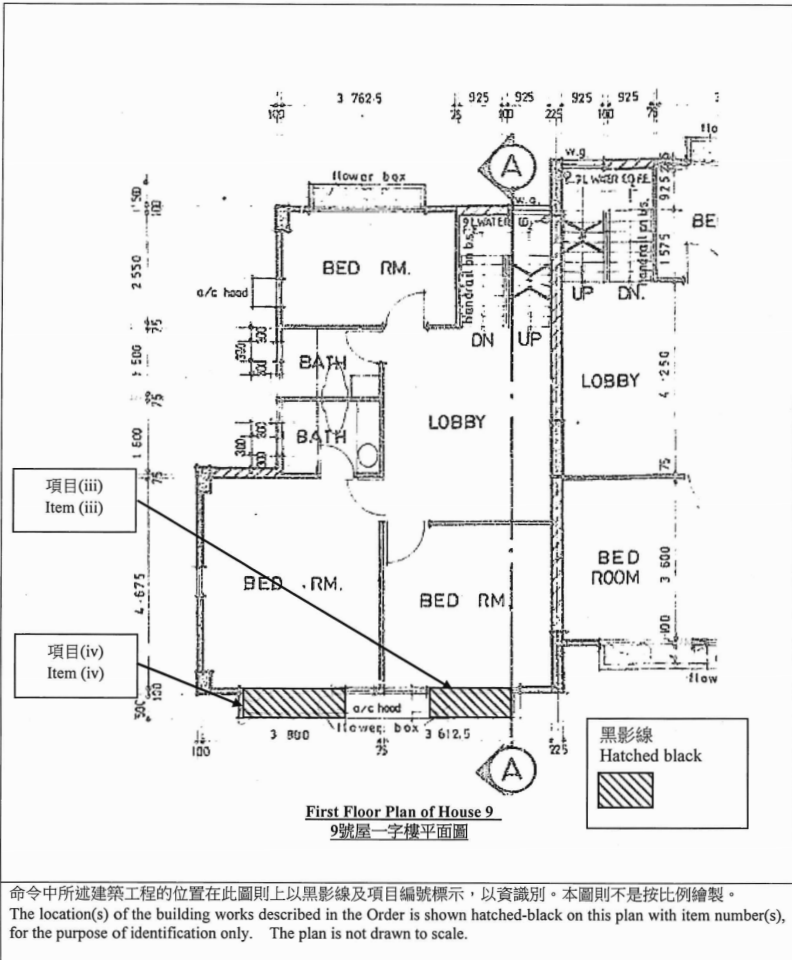

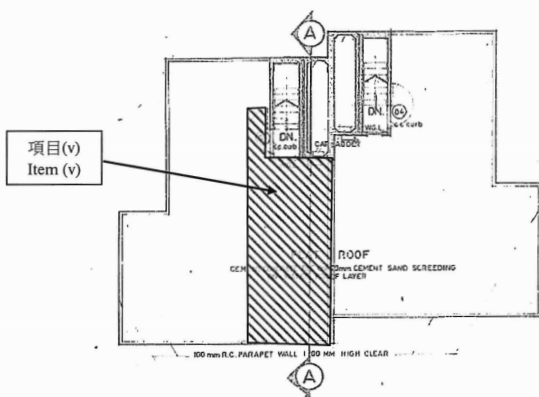

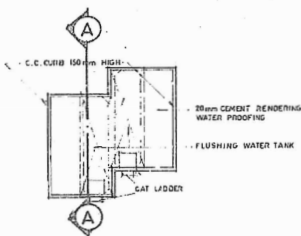
