1. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to:-

(a) demolish the building works described under item (ii) below; and

- (b) reinstate the parts of the building so affected by the building works under items (<u>ii</u>) to (<u>ii</u>) below in accordance with plans approved by the Building Authority/ minor works completion record submitted to the Building Authority.
  - (i) A door opening formed in the staircase enclosure wall; and
  - (ii) A metal gate at the door opening mentioned in item (i) above opening out on to the common staircase.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

- 2. You are required to commence the works ordered by me in paragraph 1 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.
- 3. For the said building works in paragraph 1 above:
  - (a) As a result of item (ii), Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened; and
  - (b) As a result of item (j), Section 35 of the Building (Construction) Regulation, which requires the building to be designed and constructed so as to, in case of fire, inhibit or provide adequate resistance to the spread of fire and smoke; and maintain the stability of the building, has been contravened.
- 4. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. <u>UBZ/U19-22/0008/09</u> dated 12 <u>March 2010</u> is also empowered to make this order which substitutes the previous order.
