Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. UBZ/U10-17/0006/09 dated 27 April 2012 is also empowered to make this order which substitutes the previous order.


