**Security and Guarding Services (Licensing) (Amendment)
Regulation 2023**

(Made by the Secretary for Security under section 30(2) of the Security and Guarding Services Ordinance (Cap. 460))

1. Commencement

This Regulation comes into operation on 1 July 2023.

2. Security and Guarding Services (Licensing) Regulation amended

“4. Savings

This Regulation, as in force immediately before 1 July 2023, continues to apply to a licence that was in force immediately before that date until—

- (a) if the Authority decides that the licence must be in the form prescribed in Schedule 2—the date on which the Authority provides the licensee with the licence in the form prescribed in that Schedule; or
- (b) otherwise—the date on which the licence expires, or is revoked or renewed.”.

Explanatory Note

This Regulation amends Schedule 2 to the Security and Guarding Services (Licensing) Regulation (Cap. 460 sub. leg. B) (*principal Regulation*) to replace the licence form prescribed for the purposes of section 2(2) of the principal Regulation. The licence form is applicable to a licence issued or renewed under the Security and Guarding Services Ordinance (Cap. 460) for a company to supply individuals to do certain types of security work for another person for reward.

2. This Regulation also replaces section 4 of the principal Regulation to provide for the saving arrangements for existing licences.
3. This Regulation also makes minor textual amendments to the principal Regulation.
