ROAD TRAFFIC (TRAFFIC CONTROL) REGULATIONS (Chapter 374)

RESTRICTED ZONES IN TAI PO

In exercise of the powers vested in me under regulation 14(1)(b) of the Road Traffic (Traffic Control) Regulations, Chapter 374, I hereby direct that with effect from 10.00 a.m. on 12 May 2023, the following road sections will be designated as restricted zones 24 hours daily:—

- (a) the northern kerbside lane of Chui Yi Street from its junction with Chui Lok Street to a point about 25 metres west of the same junction;
- (b) the southern kerbside lane of Chui Yi Street from its junction with Chui Lok Street to a point about 35 metres west of the same junction;
- (c) the section of Chui Wo Lane from its junction with Chui Lok Street to a point about 25 metres east of the same junction;
- (d) the eastern kerbside lane of Chui Lok Street from its junction with Tai Po Tai Wo Road to a point about 75 metres north of the same junction;
- (e) the western kerbside lane of Chui Lok Street from its junction with Tai Po Tai Wo Road to a point about 80 metres north of the same junction;
- (f) the northern kerbside lane of the eastbound carriageway of Tai Po Tai Wo Road from a point about 50 metres west of its junction with Chui Lok Street to a point about 35 metres east of the same junction;
- (g) the southern kerbside lane of the westbound carriageway of Tai Po Tai Wo Road from a point about 15 metres west of its junction with Chui Lok Street to a point about 60 metres east of the same junction;
- (h) the northern kerbside lane of the eastbound carriageway of Tai Po Tai Wo Road from a point about 45 metres west of its junction with Ting Kok Road to a point about 35 metres east of the same junction;
- (i) the southern kerbside lane of the westbound carriageway of Tai Po Tai Wo Road from its junction with Ting Kok Road to a point about 40 metres west of the same junction;
- (j) the western kerbside lane of the northbound carriageway of Ting Kok Road from a point about 80 metres south of its junction with Tai Po Tai Wo Road to a point about 40 metres north of the same junction;
- (k) the eastern kerbside lane of the southbound carriageway of Ting Kok Road from its junction with Tai Po Tai Wo Road to a point about 45 metres north of the same junction;
- (l) the southern kerbside lane of the westbound carriageway of Tai Po Tai Wo Road from a point about 25 metres east of its junction with Ting Kok Road to a point about 40 metres east of the same junction;
- (m) the southern kerbside lane of the slip road of the westbound carriageway of Tai Po Tai Wo Road leading to the southbound carriageway of Ting Kok Road;
- (n) the eastern kerbside lane of the southbound carriageway of Ting Kok Road from a point about 45 metres south of its junction with Tai Po Tai Wo Road to a point about 60 metres south of the same junction;
- (o) the section of the access road leading to Tai Po Government Offices from its junction with Ting Kok Road to a point about 10 metres west of the same junction;
- (p) the northern kerbside lane of the northbound carriageway of Ting Kok Road from its junction with Po Nga Road to a point about 40 metres east of the same junction;
- (q) the southern kerbside lane of the southbound carriageway of Ting Kok Road from its junction with Po Nga Road to a point about 40 metres east of the same junction;
- (r) the section of Po Nga Road from its junction with Ting Kok Road to a point about 45 metres west of the same junction;
- (s) the eastern kerbside lane of Kwong Fuk Road from its junction with Po Nga Road to a point about 20 metres north of the same junction;
- (t) the western kerbside lane of Kwong Fuk Road from its junction with Po Nga Road to a point about 35 metres north of the same junction;

- (u) the southern kerbside lane of Po Nga Road from a point about 130 metres west of its junction with Ting Kok Road to a point about 175 metres west of the same junction;
- (v) the northern kerbside lane of Po Nga Road from a point about 120 metres west of its junction with Ting Kok Road to a point about 175 metres west of the same junction;
- (w) the northern kerbside lane of Kwong Fuk Road from its junction with the access road leading to Tai Po Vegetable Marketing Co-operative Society Limited to a point about 15 metres east of the same junction; and
- (x) the eastern kerbside lane of the access road leading to Tai Po Vegetable Marketing Co-operative Society Limited from its junction with Kwong Fuk Road to a point about 5 metres north of the same junction.

Within the restricted zones, drivers of all motor vehicles, except franchised buses and those with permits issued by the Commissioner for Transport, will be prohibited from:—

- (a) picking up or setting down passengers; or
- (b) loading or unloading goods.

The extent of the restricted zones will be indicated by appropriate traffic signs or road markings.

At the same time, the existing restricted zones on the above road sections will be rescinded.
