Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

- 2. You are required to commence the works ordered by me in paragraph 1 above within 45 days and complete such works within 90 days of the date of this order, all to the satisfaction of the Building Authority.
- 3. For the said building works in paragraph 1 above:
 - (a) As a result of item (i) above, Regulation 30(1)(a) of the Building (Standards of Sanitary Fitments, Plumbing, Drainage Works and Latrines) Regulations, which requires that when more than one trap of a watercloset fitment is connected with one soil pipe, the traps shall be ventilated by means of anti-syphonage pipes, has been contravened.
