

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

PWP CATEGORY D ITEM
PROVISION OF PEDESTRIAN CONNECTION IN WAN CHAI NORTH—
PROPOSED PEDESTRIAN FACILITIES BETWEEN
THE HONG KONG CONVENTION AND EXHIBITION CENTRE
AND THE PEDESTRIAN LANDSCAPED DECK AT ITS WEST

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing footpath; and temporarily sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings, verge areas and amenity areas within the limit of works area as shown on Plan No. 97103/GAZ/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 641 published on 5 February 2021 and 11 February 2021. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 21 January 2022, all public or private rights in, upon, under or over the sections of the existing footpath to be permanently closed, shall be extinguished; and from 21 January 2022 to 20 January 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings, verge areas and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a footbridge (a portion of which with associated cover), lift and covered staircase between the Hong Kong Convention and Exhibition Centre and the pedestrian landscaped deck at its west, as well as other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, traffic islands, pedestrian crossings, verge areas and amenity areas on 14 January 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
