TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageways, subway carriageway, footpaths, subway footpath and amenity areas; and to close temporarily sections of the existing carriageways, subway carriageway, footpaths and amenity areas within the limit of works area as shown on Plans Nos. LW 10262 to LW 10264 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 3119 published on 12 June 2020 and 19 June 2020. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 31 January 2022, all public or private rights in, upon, under or over the sections of the existing carriageways, subway carriageway, footpaths, subway footpath and amenity areas to be permanently closed, shall be extinguished; and from 31 January 2022 to 30 January 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, subway carriageway, footpaths and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve re-alignment of Sham Shui Kok Drive, construction of roads for connection to Sham Shui Kok Chlorine Loading and Unloading Area, provision of lay-bys at Sunny Bay Road and Cheung Tung Road, as well as other ancillary works.
