To: The Owner(s) of Section E of Lot No. 1945 in D.D. 7

I am of the opinion that the formed or man-made land (Feature No. 3SW-D/C18 (Sub-division No. 1) as shown coloured red on the attached plan) at Tai Po, New Territories on Section E of Lot No. 1945 in D.D. 7 is liable to become so dangerous that it will collapse or be likely to collapse, either totally or partially, and thereby cause or be likely to cause a risk of injury to persons or damage to property.

2. In exercise of the powers vested in me under section 27A of the Buildings Ordinance, I hereby declare that such formed or man-made land is liable to become dangerous and I HEREBY ORDER you as the owner of the land, to carry out the following work :-

- a) appoint an authorized person, a registered structural engineer and a registered geotechnical engineer within TWO months of the date of this Order to co-ordinate and supervise the work required below;
- b) to carry out and complete the approved remedial/ preventive work in accordance with the proposal approved by the Building Authority on 16 August 2021 within SEVEN months of the date of this Order.

3. All work as stipulated above in this Order shall be carried out to such standard acceptable to the Building Authority and in compliance with regulations.
