

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2489EM22T, Triennial Term Contract for Maintenance of Security and Electronic Systems at Hong Kong-Zhuhai-Macao Bridge Hong Kong Port (HZMB HKP) and Other Airport Engineering Services Venues**. The scope of the Works includes provision of maintenance services, alteration, addition, replacement and improvement works of the security and electronic systems at Hong Kong-Zhuhai-Macao Bridge Hong Kong Port (HZMB HKP) and other airport engineering services venues. The Contract is scheduled to commence in July 2023 for expiry in June 2026.

Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 10 March 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 10 March 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
