

It is hereby notified that tenders are invited for **Contract No. SS M511—Construction of Public Open Space at East Coast Park Precinct, North Point (Programme No. 477RO)**.

The works include the construction of a public open space at East Coast Park Precinct, North Point, comprising a landscaped garden, a promenade, rain shelters and pavilions, a restaurant, refreshment kiosks, feature play and fitness equipment, a greenway for shared-use by cyclists and pedestrians and ancillary bicycle facility, a multi-purpose lawn area, an extreme sports park, a pet garden, a viewing deck, interactive water play feature, a community garden at the Central-Wan Chai Bypass landscape deck at Eastern Portal and other ancillary facilities such as toilets and management office; together with the enhancement works at Oil Street Sitting-out Area and all associated building services installation, drainage and external works. The site area is about 43 500 square metres. The contract is scheduled to commence in July 2023 and for completion in March 2026.

Tenderers must submit completed tenders in both soft AND hard copies before 12.00 noon on Friday, 17 February 2023.

For tender submission made in soft copy, the soft copy of the completed tenders must be submitted *via* the e-Tendering System and tenderers should ensure that data transmission must be completed before the tender closing time. Tenderers are required to use the Organizational e-Cert to sign the tender before submission *via* the e-Tendering System. Attention is drawn to the time required for the certification authority to issue the Organizational e-Cert. Tenderers are advised to apply for Organizational e-Cert well in advance of the tender closing date.

Tenderers should ensure that the accounts of the e-Tendering System are valid well in advance of the tender closing date. Tenderers with invalid accounts or accounts without valid passwords will not be able to access the e-Tendering System to download the tender documents, submit tender queries and tenders. Details of the procedures for application of an e-Tendering System account, terms and conditions, frequently asked questions and user manual of the e-Tendering System are available on the website (<https://www.gov.hk/en/theme/etendering/ets/>).

For tender submission made in hard copy, the hard copy of sealed tenders in duplicate must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time.

Late tenders or tenders not submitted *via* the e-Tendering System or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 17 February 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 17 February 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by 31 January 2023 to Chief Quantity Surveyor/1 of Architectural Services Department, at 33/F, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
