Explanatory Note

This Regulation amends the Road Traffic (Public Service Vehicles) Regulations (Cap. 374 sub. leg. D) (*principal Regulations*) to adjust certain fares specified in Schedule 5 to the principal Regulations. Under the adjustment—

- (a) for taxis licensed to operate in Hong Kong and Kowloon—
 - (i) the fare for the first 2 kilometres is increased from \$24.00 to \$27.00; and
 - (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.70 to \$1.90 until reaching \$93.50 (the current corresponding amount of which is \$83.50), and from \$1.20 to \$1.30 after reaching \$93.50;
- (b) for taxis licensed to operate within Lantau—
 - (i) the fare for the first 2 kilometres is increased from \$19.00 to \$22.00; and
 - (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.50 to \$1.70 until reaching \$175.00 (the current corresponding amount of which is \$154.00), and from \$1.40 to \$1.50 after reaching \$175.00; and
- (c) for taxis licensed to operate in the New Territories—
 - (i) the fare for the first 2 kilometres is increased from \$20.50 to \$23.50; and

- (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.50 to \$1.70 until reaching \$74.50 (the current corresponding amount of which is \$65.50), and from \$1.20 to \$1.30 after reaching \$74.50.
