

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1774EM23T, Term Contract for the Maintenance and Repair of, Alteration, Addition and Improvement Works to Electrical Installations Maintained by New Territories Maintenance Sub-division of General Engineering Services Division**. The scope of the works includes maintenance and repair of, alteration, addition and improvement works to electrical installations maintained by General Engineering Services Division of the Electrical and Mechanical Services Department. The contract is scheduled to commence in October 2024 for expiry in September 2027.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5/F, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 21 June 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
